Customer must notify Messages, Mail & More of lost or stolen card no more than 24 hrs after its loss. No liability exists beyond that time.

CUSTOMER HEREIN AGREES THAT AMOUNT OF LIABILITY OF MESSAGES, MAIL & MORE IF ANY, FOR ANY AND ALL CLAIMS ARISING OUT OF OR RELATED TO THIS AGREEMENT OR PERFORMANCE HEREUNDER SHALL NOT EXCEED THE INITIAL COST OF SERVICE REGARDLESS OF THE NATURE OF THE CLAIM.

Applicant agrees during the rental term of this Agreement to use the rented postal box for only lawful purposes and in conformity with all applicable Federal and Local Laws. Applicant further agrees to protect, indemnify and hold harmless Messages, Mail & More from and against any and all claims, demands, and causes of action of any nature whatsoever, for failure of the U.S. Postal Service to deliver on time or otherwise any item (mail, parcels etc), for damage to or loss of postal box contents by any cause whatsoever, and for any violation by applicant of applicable Federal and Local Laws.

By executing this application applicant agrees and authorizes Messages, Mail & More to release & turn over any and all documents, mail, packages arriving in its box to any Federal Authorities upon written demand.
